# What dog related activities do you participate in with your dog? (Conformation, obedience, agility, tracking, herding, therapy, flyball, etc)

In the past my dogs have been shown in Conformation. As my two Briards are now retired from the show ring, I enjoy their constant love and companionship.

**Have you bred any litters? If so, how many?** I have bred three litters. One litter I bred in 1988: Ch. Oberon le Voyageur du Lhut/ U Know It Was Meant to Bea. I am proud that bitches from this letter became foundation bitches for lines that continue to this day and this breeding is in many pedigrees.

Are you active in any other dog organizations? In what capacity? Past member/secretary of the North Central Briarders. I am not active in other dog organizations at the present time.

## What specific skills, areas of expertise or qualifications could you contribute as a board member?

Since 2017 I have been the BCA Recording Secretary. I take the responsibilities very seriously. I attend every Board meeting taking Minutes. I am responsible for all voting of the Board during meetings and online, as well as the voting of the membership. I maintain confidentiality in all voting. The buyers are being misled as to hypo-allergenic/non-shedding, etc.

## What issues do you see facing the BCA that you would like to see the Board address in the next 2 years?

The loss of members, whether by aging-out, members going to smaller breeds or just by disenchantment. The frustrations of the membership with the Board regarding many issues. The lack of participation in the BCA National.

## How would you suggest addressing these issues?

Having been the Recording Secretary since 2017 I have had the opportunity to participate in many Board meetings. Every Director has brought their knowledge and experience to the table. While it may appear to the membership that the Board hasn't heard them or doesn't address their complaints; I have witnessed hard work by every member of every Board. In the past few years there has been a turnover of some very important positions. Many committees have lost their Chairs. The BCA cannot thrive without the members. All these positions are made up of volunteers and many more volunteers are needed.

The BCA National continues to be a problem for the Board and the membership. The Board and the membership want to have the National as more than just a conformation event. At a location that has a host hotel where seminars, social events and performance events can be held. The BCA needs the membership to step up, i.e., National proposals, volunteering to help during the events, and ideas that will encourage the membership to become involved.

## How much time can you devote to Board activities?

I have devoted many hours to my job as Recording Secretary. If reelected will continue to devote as much time as necessary to the Board.

Please help in any way you can to revitalize the BCA. We all have our own opinions and beliefs. Our common thread is the love of the incredible Briard.
