## Creepy Hollow Farm

243 North Spencer Rd (Rte MA-31), Spencer, MA — GPS 42.30950, -71.98013

### Directions to the Creepy Hollow Farm

#### Note:

Some GPS or smart phone may not recognize the street address of the Creepy Hollow Farm and may take you a couple of miles south on Rte 31. You may want to use the GPS coordinates above. You should also look for a large white house on top of a hill opposite to a red barn/garage. Enter the farm on the barn side of the road. Be careful about the reduced visibility on top of the hill, when entering the farm.

#### From the Sturbridge Host Hotel

(directions from Google – 16.8 miles, 23 minutes):

From Hotel, turn right onto Rte 20 West ..... 446 ft  
Slight right onto Burgess School Rd ..... 0.1 mi  
Take the 1st left onto Rte 20 East ..... 2.7 mi  
Turn left onto Rte 49 North ..... 7.4 mi  
Turn right onto Rte 9 East ..... 0.4 mi  
Turn left onto Meadow Rd ..... 1.6 mi  
Turn left onto Rte 31 North ..... 4.6 mi  
The **Creepy Hollow Farm** will be on the right at the top of the hill.

#### From Interstate 84:

From I-84, take Exit 3A onto Rte 20 East. Continue to Rte 49 (just past the Wal-Mart on left). Turn left onto Rte 49 North. At the end of 49 turn right onto Rte 9. Just past the Big Y, turn left onto Meadow St at the light. At the end of Meadow St, turn left onto Rte 31 North **toward Paxton**, passing the Abbey on the left and Black and White restaurant on right. The farm is on the right at the crest of the hill, a large white farm house on the left and a red barn/garage on the right.

#### From Route 9 (heading West, through Worcester):

Continue on Rte 9 West into Worcester. Rte 9 is Belmont St, then Highland St. Continue on Highland St to a traffic circle. Take the second exit onto Pleasant St. Continue on Pleasant St (which becomes Rte 122) for 6.4 miles to Rte 31 in Paxton. Turn left onto Rte 31, and continue for 3.1. Follow 31 until you see the "Entering Spencer" sign on left, slow down. The farm is on the left at the top of the hill, a large white farm house on the right and a red barn/garage on the left.

## Trial Regulations

- Proof of current rabies vaccination must be furnished on request. Expulsion from the grounds may ensue if such proof is not furnished upon request.
- All dogs must be kept on leash, except during their runs. Dogs must be kept a suitable distance away from the test/trial area. Handlers should bring water and provide shade for their dogs. Handlers are required to pick up after their dogs.
- Bitches in season shall be eligible and will run at the end of the class in Tests and in catalog order as listed in the classes in Trials. Please notify the Herding Secretary before the beginning of a test class if a bitch is in season.

## Alternates

- Entrants on the alternate list must check in with the Herding Secretary no later than thirty (30) minutes prior to the start of the event. Alternates that do not have an opportunity to run shall have the entry fee refunded.

## Move-ups

- A dog may be moved up in the next test or trial, provided that the next level class is available (i.e.: offered in the premium list) and that a Judge is available, and, provided further, that the class is not filled. Notification must be made to the Herding Secretary no later than thirty (30) minutes prior to the start of the event.
